

Maine Hospital Database Payer Codes

The following codes are to be used to populate the five character UB-92 Record Type 30 Payer Identification field (#5) which will become a required field in the MHDO hospital inpatient and outpatient database submissions.

B. Military (Tricare/Champus, Martins Point, USFH, VA)	35087

Federal Employee Healthcare Benefit Program (Alliance Health Plan, APWU Health Plan, Association Benefit Plan, BC/BS Service Benefit Plan, Foreign Service Benefit Plan, GEHA Benefit Plan, Mail Handlers, NALC, PBP Health Plan, SAMBA, etc.) - <u>general code used only when specific company's Payer ID, NAIC, or MHDO codes are not available</u>	FEB00
D. MaineCare (MaineCare, Primecare, Coordinated Care, Child Developmental Services, Capitol Area Services, Breast & Cervical Cancer, Disability Determination)	10001
E. Corrections (Maine State) (Correctional Health System, Correction Medical Services, Prison Health Care System, County Jails)	COR00
F. Behavioral and Developmental Services (Maine State)	BDS00
G. Native Americans (Indian Health Services, Micmac, Passamaquoddy, Penobscot)	NAT00
H. Commercial Carriers	***

J. Other Commercial - <u>general code used only when specific company's Payer ID, NAIC, or MHDO codes are not applicable</u>	COM00
K. Workers Compensation - <u>general code used only when specific company's Payer ID, NAIC, or MHDO code does not exist and is known to be workers compensation related – WC to be retained in payer name field</u>	WC000

L. Liability – <u>general code used when payment is made for medical services by a third party that is not an insurance carrier or TPA (e.g. law firm, employer, etc.) and is not workers compensation related</u>	LIB00
M. Uninsured (uninsured, uncompensated care, charity care, self pay, grants, trusts)

*****Coding Hierarchy for Assignment to Individual Payers**

Individual companies that pay a significant number of claims in each hospital shall be assigned individual codes using the following code tables. (Hard copies of the tables are attached for your reference. Electronic versions are also available upon request.)

The individual payer code is to be selected from the:

Hospital Electronic Billing Codes (Payer ID);

If a code does not exist, then a code is to be selected from the:

NAIC Codes;

If a code does not exist in either of the two tables, then a code is to be selected from the:

MHDO Individual Payer Codes (for TPA's, PPO's, MEWAS', and Miscellaneous companies).

The three tables listed above will be incorporated into the DataBay Check software as look-up tables to be referenced when editing the UB-92 Record Type 30 Payer Identification field (#5).
